USER SAFETY RECOMMENDATIONS

Applicators and other handlers must wear long-sleeved shirt and long pants, impermeable or chemical resistant gloves, protective eyewear, and shoes plus socks. Container Disposal: Do not reuse empty container. Triple rinse during mixing and loading. Offer for recycling or reconditioning, or puncture and dispose of in sanitary landfill.

FIRST AID

IF IN EYES:

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
- Call poison control center or doctor for treatment advice.

IF ON SKIN OR CLOTHING:

- Rinse skin immediately with plenty of water for 15-20 minutes.

PRODUCT INFORMATION

Chemurgic's FOAM Annihilator contains 29.53% Principal Functioning Agents as an antifoam emulsion designed for effective use with most surfactants in aqueous formulations, over a broad pH range. It is particularly effective with nonionic surfactants.

DIRECTIONS FOR USE:

Chemurgic's FOAM Annihilator can be used as received, or after dilution with water or other suitable process liquid. For best results, the emulsion should be mixed before use. Dilution can be accomplished by mixing 3 to 10 parts of the selected diluent to one part antifoam with gentle stirring until a uniform mixture is obtained.

Continued gentle mixing of the diluted antifoam is recommended to ensure product uniformity over extended storage times.

For best results, add Chemurgic's FOAM Annihilator to the tank mix before adding the agricultural chemicals.

Recommendations: Suggested starting concentrations are 5 to 100 ppm Chemurgic's FOAM Annihilator.

NOTE: Effectiveness will depend upon composition of spray mixture, temperature, etc. Adjust Chemurgic's FOAM Annihilator concentration as necessary to achieve desired foam control.
