GENERAL INFORMATION:

Chemurgic's Magnesium 4 Llgno + is suitable for supplemental fertilization on all crop types for correction of sulfur and magnesium deficiencies.

Methods of application: May be applied directly to soil or to foliage on actively growing crops. May be used alone, with pesticides, or with other fertilizers, and may be applied using aerial, drip systems, and high- or low-volume ground sprayers.

DIRECTIONS FOR USE:

For soil applications, we recommend using this product with nitrogen fertilizer solutions.

For best uptake in foliar applications of this product:

- Thoroughly cover foliage. Complete wetting is not required.
- Apply to actively growing plants with young leaves.
- Apply just after irrigation or rainfall.
- Add urea (for example, 5 lbs. Lo-Bi Urea per 100 gal. of spray solution).

Maintenance	1 to 3 qts./acre
Mild Deficiency	2 to 6 qts./acre
Severe Deficiency	1 to 2 gal./acre

NOTE: Use lower rates for field, row and vegetable crops, and higher rates for fruit, ornamental, tree, turf and vine crops. Rates over 2 qts./acre should be split into multiple applications of 2 qts./acre or less at a minimum of 10-14 days apart.

Conventional (Dilute) Spray Applications:

The required qty/acre may be delivered in one application, however, split applications will improve overall uptake. Apply the required quantity of product with enough water for good coverage.

Ground Concentrate Applications:

Use up to 1/2 gal. of this product in a minimum of 25 gal. of water per acre per application. Repeat in 10 to 14 days if greater amounts of product are required.

Aerial Applications:

Normal aerial rate is 1 qt. of product per 5 gal. of water per acre. Maximum concentration of 1 qt. per 1 gal. of spray may be used, but adding more water will improve coverage.

Precautions: DO NOT apply when plants are moisture-stressed. DO NOT apply to deciduous tree crops during bloom.

Compatibility: *Chemurgic's Magnesium 4 Ligno* + will mix with most insecticides and fungicides. However, a jar test for compatibility should be performed prior to application. This product is not recommended for use with copper or tin fungicides.

Mixing: Agitate product container prior to application. Always add *Chemurgic's Magnesium 4 Ligno* + to the mixing tank before adding pesticides or herbicides.
