GENERAL INFORMATION: *Chemurgic's Pacific Multi-Mix Ligno+* is formulated to correct and prevent micronutrient deficiencies in various fruit, nut, vine, vegetable and row crops, and ornamentals. *Chemurgic's Pacific Multi-Mix Ligno+* is a multi-mineral source complexed with lignosulfonate. *Yucca schidigera* is added to increase wetting and improve coverage of plant surfaces.

DIRECTIONS FOR USE: For soil applications, we recommend using *Chemurgic's Pacific Multi-Mix Ligno+* with nitrogen fertilizer solutions. For best uptake in foliar applications of this product:

- Thoroughly cover and wet foliage.
- Apply to actively growing plants with young leaves.
- Apply just after irrigation or rainfall.
- Add urea (for example, 5 lbs. Lo-Bi Urea per 100 gal. of spray solution).

Compatibility: Compatible with most pesticides and fertilizers. If the desired combination has not been previously used, a compatibility test is recommended.

Mixing: Agitate product container prior to application. Always add *Chemurgic's Pacific Multi-Mix Ligno+* to the mixing tank before adding pesticides.

FOLIAR APPLICATION: Apply every 7-14 days minimum. Apply 1-4 qts./acre as needed on a 7-14 day schedule.

Precautions: DO NOT apply when plants are moisture stressed. DO NOT apply to deciduous tree crops during bloom.

SOIL APPLICATION: For Maintenance, 1-3 qts./acre. For Mild Deficiency, 2-4 qts./acre. For Severe Deficiency, 1-3 gal./acre. Use lower rates for field, row and vegetable crops, and higher rates for fruit, ornamental, tree, turf and vine crops.

If Using Fertigation: Split the recommended amount between two applications, 7-14 days apart. Continue schedule through the growing season.

Dilute Applications: Apply the recommended dose in enough water for thorough coverage.

Concentrate Applications: Use up to 2 qts. of *Chemurgic's Pacific Multi-Mix Ligno+* in a minimum of 25 gal. of water.

Aerial Applications: Up to 1 qt. of *Chemurgic's Pacific Multi-Mix Ligno+* per gal. of spray may be used, but more dilute solutions will improve coverage and results.

WARNING: This product contains boron (B) and use on crops other than fruit, nut, vine, vegetable, row crops or ornamentals could result in crop injury.

This product contains molybdenum (Mo) and use in forage crops may result in forage crops containing levels of molybdenum which are **toxic to ruminant animals**.
