*As a soil application to annual crops, a lesser response from the initial crop, with corresponding superior response from succeeding crops, may be observed. In addition, placement close to seeds or root zones may be injurious to crops. The effect may be aggravated by a soil pH below 6.5.

The high analysis and water-soluble liquid fertilizer is intended to be used as a supplemental fertilizer treatment to a well-balanced fertilizer treatment program. This product may be applied using a variety of agricultural application equipment and techniques. It is not intended to be a substitute for sound soil fertilization and conventional cultural practices.

COMPATIBILITY: *Chemurgic's 0-28*-25* has been designed to be compatible with most commonly used solutions. DIRECTIONS FOR USE:

Soil Application: *Chemurgic's 0-28*-25* can be applied to soil through various irrigation systems at a rate of 32-80 oz. per acre.

Foliar Application: *Chemurgic's 0-28*-25* can be applied to crops by air or ground at a rate of 32-64 oz. per acre.

Almonds, walnuts, pistachios and other nut crops: 32-64 oz. per acre as needed.

Citrus and deciduous fruit tree crops: 32-64 oz. per acre as needed.

Row and vegetable crops: 32-64 oz. per acre. **Greenhouse nursery, ornamentals and lawns:** 24-48 oz. per acre as needed.

Vine and berry crops: 32-64 oz. per acre as needed.

Commercial turf crops: 2–3 oz. per 1000 sq. ft. Apply as needed.

Rates Based on Application Method:

Dilute: Greater than 100 gal. water/acre.

Concentrate: 10-100 gal. water/acre.

Aerial: 5-20 gal. water/acre.

Fertigation: Apply product at rates needed to deliver desired level of nutrition.
