Mixing: Fill mixing tank half full of water, then add *Chemurgic's 20% Ferrous Sulfate*, agitating while adding remaining water and additional fertilizers. 16 oz. of a non-ionic wetting agent/100 gal. of finished spray will aid penetration of waxy leafed plants. Spray solution as soon as possible after mixing.

Compatibility:

This product is compatible with most fertilizers and pesticides except calcium and phosphate fertilizers. When mixing this product with a herbicide for the first time, a jar test is recommended. Maintain adequate agitation when mixing with amine based herbicides.
